Terms and Conditions

1. In case of defective meters, billing will be made on average consumption assessed on the basis of 3 month's previous consumption.
2. The calculation of consumption for construction purpose for 2 years on metered connection will be based on size of connection, supplies hours and average pressure in water main of the sector.
3. Material etc, for water connection will be provided by the applicant / consumers themselves. Road cutting charges etc, shall be paid by the applicant / consumers, to this Authority as per the estimates worked out by the section concerned.
4. Water charges, & security deposit shall be paid by the applicants / consumers in advance as under:-
 - i. Six months water charges in case of connection required for industrial use.
 - ii. One year advance – Water charges in case of connection is required for construction purpose.
5. The following charges shall be realized in advance:-

Water Connection Charges

½" dia	Rs.	3,000/-
¾" dia	Rs.	4,000/-
1" dia	Rs.	5,000/-
1 ½" dia	Rs.	6,000/-
2" dia	Rs.	8,000/-
2 ½ dia	Rs.	9,000/-
3" dia	Rs.	10,000/-
Disconnection / Restoration Charges	Rs.	5,000/-
